

J.P. Morgan Research Data Terms of Use

These Research Data Terms of Use (the “Terms”) describe the terms on which you may use any research content, including reports or data, including Global Financial Database (GFD) data (“J.P. Morgan Research Data”) that J.P. Morgan makes available to you in any format and via any approved third party distributor. Your use of the J.P. Morgan Research Data constitutes acceptance of these Terms, and if you do not agree to these terms, you must not use the J.P. Morgan Research Data. J.P. Morgan may change these terms at any time, with or without notice, and such terms shall be binding once such changes are posted publicly online; it is your responsibility to ensure compliance with these Terms, including any changes thereto. If you are accessing the J.P. Morgan Research Data on behalf of your employer or an organization with which you are affiliated, these Terms also bind such organization(s) and references to “you” refer to you individually and to such organization(s), and you represent and warrant that you have the ability to bind such organization(s) to these terms. To the extent you have an agreement that specifically governs your access to J.P. Morgan Research Data (including via J.P. Morgan Markets (www.jpmm.com)), to the extent there are any inconsistencies between such agreement and these Terms, such agreement shall control.

1. **Intellectual Property.** You acknowledge and agree that, as between you and J.P. Morgan, J.P. Morgan is the exclusive owner of all right, title and interest in, to and under the J.P. Morgan Research Data. You further acknowledge and agree that the J.P. Morgan Research Data is protected by copyright and other intellectual property laws and treaties around the world, and that the J.P. Morgan Research Data is arranged and prepared through the application of methods and standards of judgment used and developed through the expenditure of considerable work, time and money by J.P. Morgan and constitutes a trade secret of J.P. Morgan. You shall not: (a) use or disclose the J.P. Morgan Research Data, or the intellectual property therein, except as permitted under these Terms or with J.P. Morgan’s prior written consent, or (b) take any action that would infringe, misappropriate or otherwise violate or impair such intellectual property rights. Nothing in these terms shall grant you the right to use J.P. Morgan’s name or trademarks without J.P. Morgan’s prior written consent. You shall promptly notify J.P. Morgan in writing of any written threats, warnings or notices relating to any claim or action adverse to such intellectual property rights by emailing Research.Access@jpmorgan.com. You acknowledge and agree that the J.P. Morgan Research Data may include content protected by the intellectual property rights of third parties, and you agree to abide by any restrictions imposed by such third parties on the use of their intellectual property.
2. **Proper Use.** You shall use the J.P. Morgan Research Data only for your internal business purposes; and you shall not permit the use of the J.P. Morgan Research Data by any personnel involved in transacting with customers or clients in a manner customarily deemed as a “sell-side activity” including, but not limited to, market-making or general brokerage business and services. You may not distribute the J.P. Morgan Research Data in any form without the express prior written consent of J.P. Morgan. You shall not create any derivative work from the J.P. Morgan Research Data, nor shall you refer to or otherwise use the J.P. Morgan Research Data as part of any effort to either: (a) develop data having any functional attributes or other features similar to those of the J.P. You shall reproduce all copyright, trademark and other proprietary notices and disclaimers (“Notifications”) regarding the J.P. Morgan Research Data and shall not

directly or indirectly: (x) alter, remove or conceal any Notifications; (y) modify, copy, translate, recompile, decompile, disassemble and/or reverse engineer the J.P. Morgan Research Data; and/or (z) grant any rights in, permit and/or provide access to the J.P. Morgan Research Data, in each case of the foregoing clauses (x), (y) and (z), in a manner that could infringe the intellectual property rights of J.P. Morgan or any third party or violate any applicable laws, tariffs, rules and/or regulations. You shall not use the J.P. Morgan Research Data to conduct any type of data licensing, service bureau, or time-sharing business or operation, whether on a fee basis or otherwise. For the avoidance of doubt, without prior written consent from J.P. Morgan, you are prohibited from using or sharing any J.P. Morgan Research Data in any artificial intelligence (“AI”) systems or models when such J.P. Morgan Research Data is accessible by a third party. It is permissible to use J.P. Morgan Research Data for internal business purposes only in an AI system or model that protects the confidentiality of the J.P. Morgan Research Data so as to prevent any and all access to or use of such J.P. Morgan Research Data by any third party. The J.P. Morgan Research Data shall not be: (1) used to train, update or fine-tune any AI systems or models, or (2) logged, stored or saved in any manner by such AI systems or models (except in connection with transient, in-memory storage necessarily associated with the use of such AI system or model to generate a single response or in connection with conversational session windows, short-lived caching, or context windows, provided, in each case of the foregoing, any session history or caches are automatically deleted within 72 hours and do not persist across unrelated sessions).

3. No Warranties; Limitation on Liability; Indemnity.

- a) You acknowledge and agree that J.P. Morgan is not and shall not be deemed to be acting in a fiduciary or advisory capacity, shall not be providing you with any financial, tax, accounting, legal or any investment advice, and is not making recommendations to or suitability determinations for you regarding securities transactions or trading strategies. You further acknowledge and agree that the J.P. Morgan Research Data provided hereunder may or may not be the same or similar tools and data that J.P. Morgan and its affiliates utilize for their own internal use.
- b) J.P. Morgan, its affiliates and its third-party sources of data, and all related directors, officers, agents and employees (collectively, the “Indemnified Parties”) provide the J.P. Morgan Research Data “as is” and “as available” and without any representations or warranties of any kind whatsoever, whether express or implied, including, without limitation: (i) any warranty of merchantability, fitness for a particular purpose, or non-infringement, (ii) regarding the results to be obtained from the use of the J.P. - c) IN NO EVENT WILL THE INDEMNIFIED PARTIES BE LIABLE FOR ANY DIRECT, INDIRECT, SPECIAL, CONSEQUENTIAL, INCIDENTAL, COMPENSATORY, EXEMPLARY OR PUNITIVE DAMAGES (INCLUDING, BUT NOT LIMITED TO, LOSS OF USE, LOST PROFITS OR REVENUE OR OTHER ECONOMIC LOSS SUFFERED BY YOU OR ANY THIRD PARTY) WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE EVEN IF THE INDEMNIFIED PARTIES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. d) YOU SHALL PROMPTLY INDEMNIFY AND HOLD THE INDEMNIFIED PARTIES HARMLESS FROM AND AGAINST ALL LOSSES, CLAIMS, DAMAGES, LIABILITIES, OBLIGATIONS, PENALTIES, TAXES, JUDGMENTS, AWARDS AND RELATED EXPENSES, INCLUDING THE FEES, CHARGES AND DISBURSEMENTS OF ANY COUNSEL FOR ANY INDEMNIFIED PARTY (COLLECTIVELY, “COSTS”) INCURRED BY OR ASSERTED AGAINST ANY INDEMNIFIED PARTY ARISING OUT OF, IN CONNECTION WITH, OR AS A RESULT OF THESE TERMS OR THE USE, DISCLOSURE OR DISTRIBUTION OF ANY THE J.P. MORGAN RESEARCH DATA BY OR FOR YOU OR TO A THIRD-PARTY, OR ANY BREACH OF THESE TERMS BY YOU WHETHER OR NOT IN CONNECTION WITH PENDING OR THREATENED LITIGATION TO WHICH ANY INDEMNIFIED PARTY IS OR MAY BECOME A PARTY, IN EACH INSTANCE AS SUCH EXPENSES ARE INCURRED OR PAID.
4. Governing Law. These Terms shall be governed by and construed in accordance with the laws of the State of New York applicable to agreements entered into and performed in their entirety within such state. You consent specifically to the exclusive jurisdiction of the federal courts of the United States sitting in the Southern District of New York and the courts of the State of New York sitting in the County of New York (and any court to which an appeal therefrom may be taken) for purposes of all legal proceedings arising out of or relating to these Terms. You expressly disclaim the applicability of, and waive any rights based upon, the Uniform Computer Information Transactions Act or the United Nations Convention on the Sale of Goods. YOU IRREVOCABLY WAIVE YOUR RIGHT TO A TRIAL BY JURY IN RESPECT OF ANY PROCEEDINGS RELATED TO THESE TERMS.
